YOUTH MEMBERSHIP REQUIREMENTS

- Social Security Number, date of birth, mothers maiden name, physical address. and TWO of the following documents:
 - Birth Certificate
 - Social Security Card
 - School photo ID
- Parent, grandparent, or legal guardian must sign for minor

 Once the child turns 9, their Fox Friends sub account will be closed. They will automatically be enrolled in Penny's Pals. Funds will be transferred to their new sub account and they will receive the proper items for Penny's Pals.

- · Receive \$1 Fox Funds for every \$15 deposit o maximum of \$5 Fox Funds can be collected per day
- · Redeem Fox Funds at Fox Den Store
- Penny's Pals can redeem from Tiers 1-5

WHAT HAPPENS WHEN THEY TURN 13?

. Once the child turns 13, their Penny's Pals sub account will be closed. They will automatically be enrolled in Penny's Pack. Funds will be transferred to their new sub account and they will receive the proper items for Penny's Pack.

ACCOUNT OPENING/PERKS

- Complete and sign (by child) Penny Program Application
- Receive Stamp Booklet and \$10 gift card
- Penny's Pack sub account will be added to their personal account
- · Receive birthday card redeem for extra stamps!
- Receives 1.00% APY*

HOW TO EARN + REDEEM STAMPS

- \$20 \$99: 2 stamps / \$100 \$200: 4 stamps / \$201+: 5 stamps
- Earn double stamps at graduation
- Redeem 30 stamps for \$10 gift card of choice (based on card stock)

WHAT HAPPENS WHEN THEY TURN 18?

. Once the child turns 18, their Penny's Pack account will be closed and funds will be transferred to their Regular Shares account. Any outstanding stamps can be redeemed for gift cards.
